# I. General: Licensing and pricing changes

## 1. Which Acronis Cyber Cloud solutions do the new licensing and pricing changes affect?

The Acronis Cyber Cloud solutions that will be affected by the new licensing and pricing are Acronis Cyber Protect Cloud, Acronis Cyber Backup Cloud, and Acronis Cyber Disaster Recovery Cloud. The changes are as follows:

- Acronis Cyber Protect Cloud** will not be licensed through different editions. The Essentials, Standard, and Advanced editions will exist as legacy editions only. In their place, Acronis is introducing a single solution — Acronis Cyber Protect Cloud. This will offer essential cyber protection functionality, including security, enhanced backup functionality, disaster recovery, management, file sync and share, and notary features. Some features will be part of different advanced packs that can be added to the product in any combination, providing more options for service providers to deliver customized cyber protection by mixing and matching the packs and protection their clients need. Acronis Cyber Protect Cloud and all advanced packs will be licensed on both a per-GB and a per-workload model.



- Acronis Cyber Backup Cloud** will no longer exist as a standalone product. The majority of backup functionalities will be available in Acronis Cyber Protect Cloud, and some advanced features will be available in the Advanced Backup pack that can be added to the main product through both the per-GB and per-workload models with competitive, pay-as-you-go pricing.
- Acronis Cyber Disaster Recovery Cloud** will no longer exist. Essential disaster recovery functionality will be available in Acronis Cyber Protect Cloud and advanced disaster recovery functionality will be available in the Advanced Disaster Recovery pack that can be added easily to the main product through both the per-GB and per-workload models.

Pricing and licensing for partners who use Acronis Cyber Files Cloud, Acronis Cyber Notary Cloud, Acronis Cyber Cloud Physical Data Shipping Service, and Acronis Cyber Infrastructure remain unchanged.

## 2. When will the new pricelist be in effect?

The effective date of the new licensing model and pricelist is March 31, 2021.

## 3. Will I have to migrate to the new licensing and pricing models?

Yes, all partners who are affected by the licensing and pricing changes will have to migrate to the new model.

Acronis will provide partners with a migration guide for main migration scenarios.

## 4. Will there be a grace period before I'm required to migrate to the new licensing and pricing models?

Yes, the grace period will be three months, starting from March 31, 2021.

All partners affected by the licensing and pricing changes will need to migrate before June 30, 2021.

## 5. What is the migration process? Will clients automatically switch to the new model after the three month grace period?

No, the migration isn't automatic. It's up to partners to choose the proper services and advanced packs for their clients. Advanced packs can be managed in the customer tenant settings under the "Configure" menu. Partners should select the client and then apply a pack. There will also be a special script for those partners who want to switch multiple clients on the new licensing at once.

## 6. What if I'm still using the legacy editions (Acronis Cyber Cloud 9.0)?

All partners who are still using the legacy editions (Standard, Advanced, and Disaster Recovery) can migrate directly to the new licensing model. The grace period will be the same - three months, starting from March 31, 2021.

## 7. How will billing be handled after the change?

Billing will be handled in the same way. Partners will be billed for the items they offer in accordance with their current price tier and minimum monthly commitment terms.

## 8. If I don't want to change licensing models, how long can I keep the legacy pricing?

Legacy pricing will be available for three months after March 31, 2021. Partners will need to migrate to the new pricing before June 30, 2021.

Please note that for most partners the new pricing will be equal or even cheaper, with essential cyber protection and SP-ready management features included at no cost.

## 9. Did Acronis study how these changes will affect partners?

Yes, please refer to the table below to check some example calculations, if using Acronis Hosted storage, Tier 1 with a Minimum Monthly Commitment of USD 250.

## 10. What is the new licensing metric for Acronis Cyber Protect Cloud?

With the new model, Acronis Cyber Protect Cloud can be licensed both per-GB and per-workload.

## 11. Can I buy per-GB licenses for Acronis Cyber Protect Cloud?

Yes, Acronis Cyber Protect Cloud will be licensed per-GB.

## 12. If Acronis Cyber Backup Cloud is no longer a standalone product what happens to my current clients?

Acronis Cyber Backup Cloud will no longer exist as a standalone product, which means that Acronis will not have a backup-only product in its portfolio. Acronis believes that backup alone is not enough to protect data and clients' protection can be ensured only through an integration of backup, cybersecurity, and management.

Acronis Cyber Backup Cloud's trusted technology and features will not be eliminated though. The majority of backup functionalities such as cloud file-based and image-based backups will be part of Acronis Cyber Protect Cloud and continuous data protection, data protection maps, application-aware SAP HANA, Oracle Database backup, etc. will be a part of the Advanced Backup.

All clients who are using Acronis Cyber Backup Cloud Standard per-GB can switch to Acronis Cyber Protect Cloud per-GB and continue using the same backup functionalities, plus security for the selected workloads, without any price increase.

All clients who are using Acronis Cyber Backup Cloud Standard per-workload can switch to Acronis Cyber Protect Cloud per-workload and continue using the same backup functionalities, plus security features for the selected workloads, without any price increase.

## 13. Currently, Microsoft SQL Server backup is available in Acronis Cyber Backup Cloud Standard. With the new licensing, will partners need to license the Advanced Backup to back up Microsoft SQL Server?

In order to back up Microsoft SQL Server, partners will need to license Acronis Cyber Protect Cloud only. However, backing up Microsoft SQL Server cluster will require the Advanced Backup. This functionality is not supported in Acronis Cyber Backup Cloud Standard either.

## 14. If Acronis Cyber Disaster Recovery Cloud will no longer exist what happens to my current clients?

Acronis Cyber Disaster Recovery Cloud will no longer exist but essential disaster recovery functionality will be available in Acronis Cyber Protect Cloud and advanced disaster recovery functionality will be available in the Advanced Disaster Recovery. If your clients need advanced disaster recovery features, the Advanced Disaster

Recovery can be added easily to the main product in both the per-GB and per-workload models. With it, clients can continue access to features such as runbooks, production and test failover, and cloud only and site-to-site VPN connections.

All clients using Acronis Cyber Protect Cloud with the Acronis Cyber Disaster Recovery Cloud Add-on can switch to Acronis Cyber Protect Cloud either per-GB or per-workload, add the Advanced Disaster Recovery, and access advanced disaster recovery features without any price increase.

## 15. How will switching to Acronis Cyber Protect Cloud from Acronis Cyber Backup Cloud affect my costs?

Partners switching from Acronis Cyber Backup Cloud Standard (per-GB or per-workload) to Acronis Cyber Protect Cloud (per-GB or per-workload) will not be negatively affected. There will be no price increase. Partners will continue paying the same while gaining additional security and management features such as cloud signature-based file detection, group management of devices, centralized protection plans, etc.

## 16. What will happen with the application programming interface (API) used by partners for provisioning Acronis Cyber Backup Cloud Standard and Acronis Cyber Protect Cloud (Essentials, Standard, and Advanced editions)?

There will be no changes for a longer period. The current editions will be in the system, they won't be visible in the user interface (UI) but they will stay in the API. This longer period (up to a year after June 30, 2021) is an extended grace period to support partners and make the migration process smoother.

## 17. Can I use Acronis Cyber Protect Cloud without the pay-as-you-go features? Will it cost anything?

Yes, partners can leverage Acronis Cyber Protect Cloud without the pay-as-you go features. Acronis Cyber Protect Cloud can be installed on as many machines as partners like and Acronis will not charge if partners don't consume backup, file sync and share, or notary storage. Standard configuration includes paramount cyber protection features to immediately increase the security and manageability of your endpoints at no charge. ## 18. Will there be free Acronis Hosted storage included in Acronis Cyber Protect Cloud offering?

No, there won't be free Acronis Hosted store included in Acronis Cyber Protect Cloud anymore, but this won't lead to any price increase, partners will pay the same.

## 19. Will I get any credit or discount for moving to Acronis Cyber Protect Cloud?

No credit or discounts are planned for partners migrating to Acronis Cyber Protect Cloud and/or using the advanced packs. Instead, partners will get essential cyber protection functionality at no cost and ensure further protection with pay-as-you-go features and/or advanced packs without any price increase.

## 20. Will partners have access to any training materials on the Acronis Partner Portal regarding the new licensing model?

Yes, the first training for partners is planned for the beginning of March, more will be available after.

## 21. Where can I find a new pricelist and SKUs?

## 25. The new licensing model includes four hours per month for test failover in an isolated network environment in Acronis Cyber Protect Cloud. Is there any limitation based on the type of virtual machine (VM)?

Yes, there will be certain limitations. Test failover will be limited to four sessions by one hour each and to virtual machines (VMs) type F1 (1 vCPU, 2 GB of RAM) and F2 (1 vCPU, 4GB of RAM).

## 26. Are advanced packs applied to an entire tenant?

No, a customer tenant can leverage multiple advanced packs in both per-GB and per-workload models. This will give partners more flexibility to deliver customized cyber protection in an easy, efficient, and secure way by mixing and matching the packs and protection their clients need.

## 27. Which advanced pack is right for me?

Different advanced packs extend different functionalities for you to offer clients. To choose the right advanced pack, it's important to know the different functionalities available in them. This will allow partners to customize and differentiate their cyber protection offerings for their own partners and clients while providing the specific functionalities that meet their needs and budget.

- **Advanced Backup:** Ensure your client workloads are protected with advanced backup and recovery features
- **Advanced Security:** Ensure your client workloads are protected with next-generation cybersecurity features
- **Advanced Management:** Gain greater control with this SP-ready advanced protection management pack
- **Advanced Disaster Recovery:** Ensure your client workloads are protected with world-class disaster recovery features
- **Advanced File Sync and Share (Q2):** Extend your clients' file sync and share capabilities with secure notarization and e-signature services
- **Advanced Email Security (Q2):** Protect your clients' easiest point of entry with advanced email security features
- **Advanced Data Loss Prevention (Q3):** Provide advanced data loss prevention features to your clients and stay ahead of threats
- **Advanced Security + Endpoint Detection and Response (EDR) (Q4):** Ensure your client workloads are protected with advanced endpoint threat detection, investigation, and response features

## 28. Why are these advanced packs needed? What are the benefits of this approach?

Advanced packs give service providers the opportunity to extend their offerings and provide further protection to their clients. The main benefit of the advanced packs approach is that service providers can maintain simplicity while adding even more flexibility by choosing and applying only features their clients find important.

With the new pack licensing, service providers can improve their offerings with integrated protection and mix and match advanced pack capabilities for optimal protection of every workload.

### 30. Functionalities such as patch management, fail safe patching, and remote assistance were included in Acronis Cyber Protect Cloud Essentials edition. Why should I pay more for the same functionalities by licensing the Advanced Management?

Remote assistance is available at no cost in Acronis Cyber Protect Cloud, while patch management and fail-safe patching are indeed part of the Advanced Management. However, with the Advanced Management partners get even more features such as HDD health monitoring, software inventory, cyber scripting, and more in the future – all at a highly competitive price.

### 31. If a client has mixed requirements, can they license multiple advanced packs?

Yes, customer workloads can be protected by one, multiple, or all advanced packs in both the per-GB and per-workload licensing models.

### 32. How can I enable or disable an advanced pack?

You can easily enable or disable an advanced pack via the Acronis Cyber Cloud management console.

### 33. Can I add all advanced packs to the functionalities at no cost?

No, not all advanced packs can be added to the security and SP-ready management features. This is because some of the advanced packs extend pay-as-you-go features.

## III.Licensing models

### 34. Can I, as a service provider, leverage both models: per-GB and per-workload?

Yes, partners can leverage both per-GB and per-workload models via one management console, and under one commitment.

### 35. Which licensing model is better for me?

To choose the licensing model that is right for your clients consider how each option lets you optimize their costs.

- The per-GB licensing model is beneficial for clients with a high number of workloads that protect a small amount of data per workload.
- The per-workload licensing model is beneficial for clients with a small number of workloads yet larger data sets per workload.

### 36. Can clients leverage both models: per-workload and per-GB?

No, on a customer level, a client can have only one licensing model – either per-GB or per-workload.

### 37. Will advanced packs be available for both the per-workload and per-GB licensing models?

Yes, all advanced packs can be added to both per-GB and per-workload licensing models.

### 38. In the per-GB licensing model, will service providers be charged for an advanced pack based on the workload on which the advanced pack is enabled?

Yes, all advanced packs can be applied to both per-GB and per-workload models, but they will be priced per-workload.

40. What if I'm a service provider who uses Acronis Cyber Protect Cloud per-GB and a new client needs Acronis Cyber Protect Cloud with Advanced Backup in the per-workload model? Will my whole service provider (SP) tenant need to switch to the per-workload model?

No, partners can mix the two pricing models – per-GB and per-workload. They can offer Acronis Cyber Protect Cloud per-GB to one client and Acronis Cyber Protect Cloud with Advanced Backup per-workload to another. An SP tenant has all available options.

41. With this change I will need to update the contracts with my clients and every time I do so I risk churn. What should I do?

The contract that a partner has with their clients can be independent of the contract a partner has with Acronis. It's up to the partner to decide how to charge and license their clients.

## V. Microsoft 365 and Google Workspace promo (per-workload model only)

### 42. What is the Microsoft 365 promo?

Microsoft 365 promo includes unlimited cloud storage at no cost for personal data, meaning data generated by a Microsoft 365 seat (mailbox and OneDrive). Acronis won't charge partners for the number of protected Microsoft Teams and SharePoint Online sites, but will charge for the storage generated by them.
